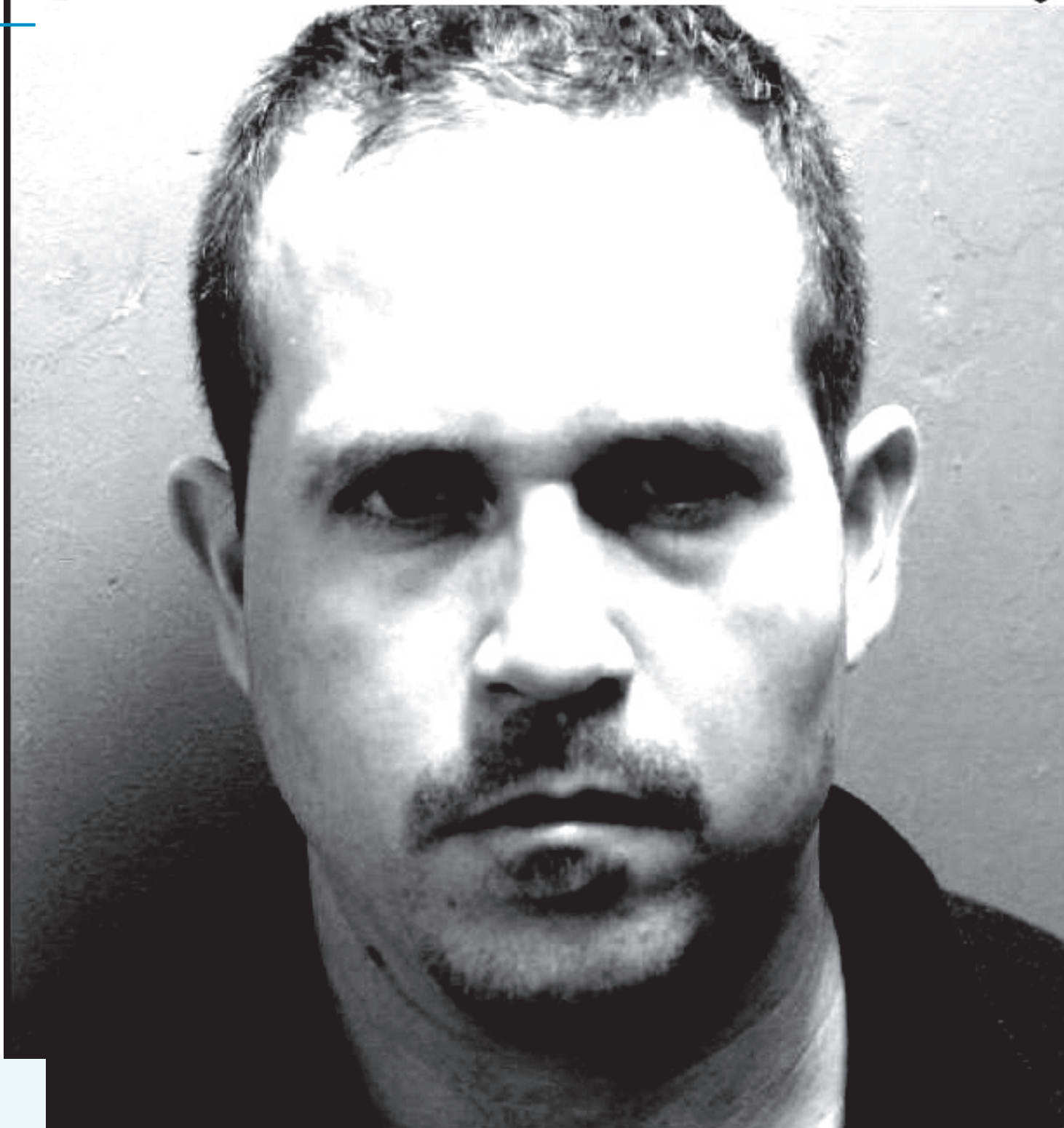

CONSTABLE INVESTIGATORS SHUT DOWN ILLEGAL GAME ROOM ESTABLISHMENT

Details: On December 27, 2018, investigators with Constable Mark Herman's Criminal Investigations Division executed a search warrant at the Valero Gas Station located in the 6100 block of FM 1960 East after receiving numerous complaints of illegal gambling from concerned citizens.

As a result, Constable Investigators seized illegal gambling devices, approximately \$5,100.00 U.S Currency believed to be illegal gambling proceeds, and documents supporting the illegal gambling within the business store.

Store employees, Mohammad Mehedi Hasan and Muhammad Yasir Hashmi were arrested

and booked into the Harris County Jail, charged with Possession of Gambling Equipment. Their bonds were set at \$1,000.00 each out of County Court 4.
