On February 24, 2019, a deputy with Constable Mark Herman's Office conducted a traffic stop on a motor vehicle in the 7600 block of W FM 1960 who was stopped in a moving lane of traffic. The driver was identified as Christine Martinez who displayed several signs of intoxication.

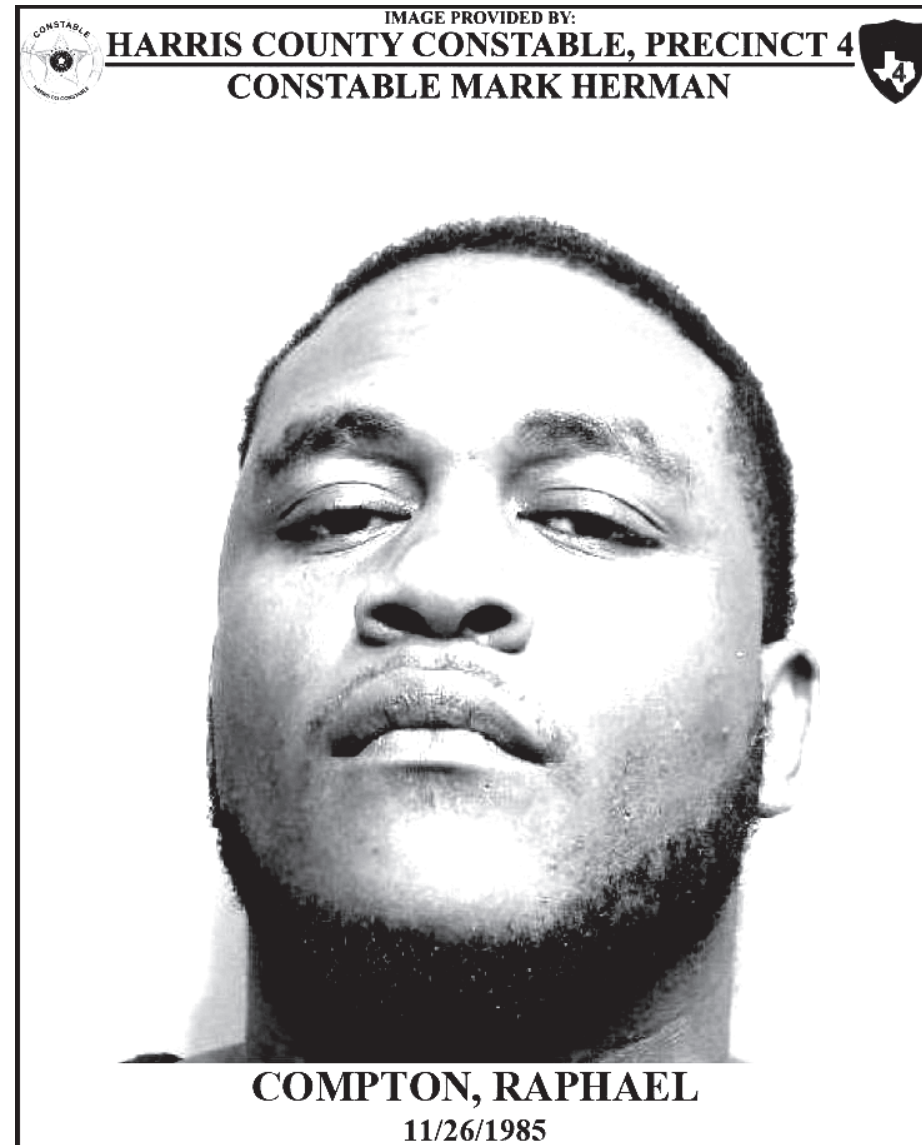
Standardized Field Sobriety Tests were administered and it was discovered that she was driving while intoxicated.

During the search the vehicle, Constable Deputies located 7.2 grams of cocaine. All contraband was seized and stored into evidence.

Details:

On February 23, 2019, deputies with Constable Mark Herman's Office responded to a residence in the 4200 block of Burkegate Drive to execute a warrant on a wanted Aggravated Assault suspect, Raphael Compton. Upon deputies arriving, they observed a vehicle occupied by a female driver and the wanted suspect approach the residence. The vehicle made a U-turn and quickly fled away from deputies. The suspect then exited the vehicle and fled on foot.

Constable Deputies gave chase and were able to locate and detain him. The female driver was also detained and identified as Antanika Perry.

"Raphael Compton and Antanika Perry were arrested and booked into the Harris County Jail. Raphael Compton was booked in on the Aggravated Assault warrant. His bond was set at \$40,000.00 out of the 339th District Court. Antanika Perry was charged with Hindering Apprehension. Her bond was set at \$2,500.00 out of the 228th District Court." -Constable Mark Herman
