crab.

"I'm tickled pink," Samuelson said. "The president recognized our great fisheries out here and how important they are to the people of Bristol Bay and the nation."

Obama and former Interior Secretary Ken Salazar announced in March 2010 that a planned 2011 lease sale in what the Interior Department refers to as the North Aleutian Basin would be canceled. Salazar cited a lack of infrastructure and the bay's valuable natural resources.

The temporary withdrawal was set to expire in 2017. Obama's decision Tuesday under authority of the Outer Continental Shelf Lands Act of 1953 withdraws the area permanently.

U.S. Sen. Lisa Murkowski, R-Alaska, said she's not objecting to the president's decision at this time, given the industry's lack of interest in the area and a public divide over allowing oil and gas exploration there.

"I think we all recognize that these are some of our state's richest fishing waters," she said. "What I do not understand is why this decision could not be made within the context of the administration's upcoming plan for offshore leasing - or at least announced at the same time."

According to the White House, Republican President Dwight Eisenhower was the first to use presidential authority to withdraw acreage from offshore drilling consideration. Eisenhower in 1960 withdrew an area now included in the Florida Keys National Marine Sanctuary, and presidents from both parties

ity for consumers. They also contend the state shouldn't pick winners and losers in markets.

Supporters of the law counter that there's no evidence it has contributed significantly to higher electric bills and warn that repealing it will discourage investment in wind energy. State Sen. Marci Francisco, a Lawrence Democrat, said the rule is also important with the federal government pursuing stronger air-pollution regulations.

Kimberly Svaty, a lobbyist for the Wind Coalition, said the industry has "never drawn the line in the sand," but said the renewable-energy rule has spurred investment and created jobs.

"The policy stability is really a key component," she said.

Brownback calls himself a strong supporter of wind energy because of its potential on the frequently gusty Plains, but he said in July that he's open to phasing out the state's rule because wind is no longer a fledgling industry in Kansas. He's also called several times for the industry and opponents of the renewable-energy mandate to work out a compromise.

"I want everybody in the room to develop whatever would be considered for a change," he said last week.

Westar spokeswoman Gina Penzig said the utility is not taking a position in the debate, viewing the rule as "a policy decision left up to our state leaders."

"We were motivated by customer preferences and cost," she said.
