tariffs, short-term economic growth and energy demand might be stronger than feared.

Also, the Alberta premier announced that the Canadian province will trim production by 8.7 percent because a shortage of pipeline capacity has caused a glut of Canadian crude. Canada is the largest source of oil imported by the U.S.

Finally, the small but wealthy Persian Gulf nation of Qatar said Monday that it will leave OPEC in January. Qatar has been feuding with Saudi Arabia and three other Arab nations that accuse it of financing terrorism.

Qatar is one of the smallest oil producers in OPEC, so its departure will have only a marginal impact on the cartel's share of the world's supply. Still, the surprising announcement by Qatar's energy minister underscores the political tension within OPEC, "which doesn't necessarily make it easier to come to a decision" on cutting production, said JBC Energy analyst David Wech.

Some analysts expect OPEC and Russia will agree to even larger cuts, about 1.5 million barrels a day. Anything less, they say, could set the stage for continued global oversupply next year and send oil prices lower.

OPEC must produce "a credible agreement" to cut output by about 1.5 million barrels a day for oil prices to recover their recent losses, Credit Suisse analyst William Featherston wrote in a note Monday. The Saudis, he said, will have to bear the largest share of cuts.

Saudi Arabia seems eager to reduce supply, Featherston said, but the kingdom's decision is complicated by President Donald Trump's desire for lower prices and the Saudis' wish to improve relations with the U.S. after the murder of journalist and U.S. resident Jamal Khashoggi.

tors had pursued a draft 57-page indictment that was never filed.

Instead, under the deal, Epstein pleaded guilty in 2008 to two sex-related state charges, served 13 months in jail, paid financial settlements to many of the accusers and registered as a sex offender.

The plea agreement did not become public until several years later. Some of Epstein's accusers are now arguing that their rights were trampled under a federal law that says crime victims must be informed about plea bargains.

One of Epstein's lawyers, Roy Black, said in court papers that there was no conspiracy to violate victims' rights, and the plea bargain "was no sweetheart deal by any stretch of the imagination."

Epstein at the time had a Palm Beach mansion where authorities say many of the girls were brought for sexual encounters.

Before the scandal broke, Epstein's friends included Trump, who told interviewers Epstein was "a great guy." Records show former President Bill Clinton flew on Epstein's jet more than two dozen times. One young woman alleged in court documents that Epstein shared her with his friends, including Britain's Prince Andrew, a charge denied by Buckingham Palace.

Epstein's legal team at various times included such big names as Whitewater prosecutor Kenneth Starr and Harvard professor Alan Dershowitz.

Neither Trump nor Clinton has been accused of any wrongdoing related to Epstein.

Acosta has not commented about the case during recent news coverage surrounding the lawsuit. He was asked briefly about the non-prosecution agreement at his Senate confirmation hearing to be labor secretary.

"At the end of the day, based on the evidence, professionals within a prosecutor's office decided that a plea that guarantees someone goes to jail, that guarantees he register (as a sex offender) generally and guarantees other outcomes, is a good thing," he replied.

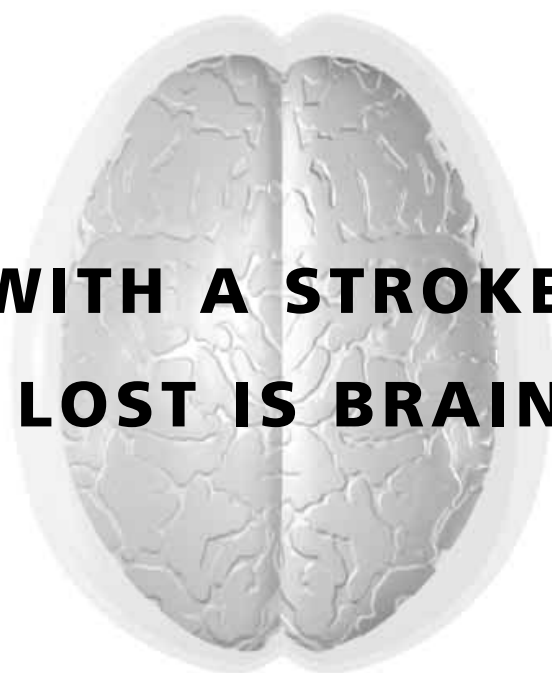
Their comments came two weeks after U.S. envoy to Syria James Jeffrey said Tice is believed to be alive and held hostage in Syria. He didn't say why officials believe this or who might be holding him.

In April, federal authorities for the first time offered a reward of up to \$1 million for information leading to Tice, a former Marine who has reported for The Washington Post, McClatchy Newspapers, CBS and other outlets.

It's not clear what entity is holding him, and no ransom demand has ever been made. An FBI poster released this year urges people to report any information that could lead to his location, recovery or return. The White House envoy for hostage affairs, Robert O'Brien, said last month that the administration is working to bring him home.

"What the president communicated to us was an absolute commitment to work very hard to bring Austin safely home," Marc Tice said.
