ORDINANCE NO. 2019-045

An Ordinance authorizing and approving transfer to Lone Star NGL Pipeline, LP of one (1) 20" natural gas liquids (NGL) pipeline franchise granted by Ordinance No. 2011-169 to ETC NGL Transport, LLC; providing a savings clause; and providing for severability.

WHEREAS, Lone Star NGL Pipeline, LP has requested approval of a transfer of one (1) 20" natural gas liquids (NGL) pipeline franchise to Lone Star NGL Pipeline, LP of pipeline franchise granted by Ordinance No. 2011-169 to ETC NGL Transport, LLC (see Exhibit "1" attached hereto and incorporated herein for all purposes); and

WHEREAS, Lone Star NGL Pipeline, LP has paid the appropriate transfer fee; and WHEREAS, the Director of Public Works has recommended such transfer and requested this ordinance; and

WHEREAS, the Director of Planning has recommended such transfer; NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PASADENA:

SECTION 1. That the pipeline franchise granted through Ordinance No. 2011-169 is hereby transferred to Lone Star NGL Pipeline, LP. The mailing address and phone number for Lone Star NGL Pipeline, LP is Lone Star NGL Pipeline, LP, Attn: ROW Dept., 1300 Main Street, Houston, Texas 77002, Office: 833-633-3769, Fax: 713-989-1209.

SECTION 2. That the approval of this transfer is contingent upon the application of all terms and conditions of present day pipeline franchise ordinances to this ordinance.

SECTION 3. Lone Star NGL Pipeline, LP shall, as a condition of this fran-

chise, at all times by separate instrument keep the City apprised of valid and functioning emergency and non-emergency address and telephone number(s) by which the City may contact the Grantee when necessary. Such contact information shall be kept current and updated by Grantee in writing sent to the following:

1) City Controller, P. O. Box 672, Pasadena, Texas 77501; 2)Director of Public Works, P. O. Box 672, Pasadena, Texas 77501; 3) Fire Chief, P. O. Box 672, Pasadena, Texas 77501, (713) 475-5554 Such notice shall be made within a reasonable time after the pipeline transfer, company name change or other event causing such change but, in no event shall notification to City be more than thirty (30) days after the event causing the change has occurred.

Failure to timely apprise City as required by this section shall result, upon approval by the City Council of the City of Pasadena, Texas, in a penalty of \$100 per day for every day the notification is past thirty (30) days after the event causing the change has occurred.

SECTION 4. That Lone Star NGL Pipeline, LP shall file its written acceptance of this franchise, a facsimile of which is attached hereto as Exhibit "2", with the City Secretary of the City of Pasadena within thirty (30) days from the date of passage hereof, and shall thereupon be bound by all of the terms and conditions of franchise agreement under Ordinance No. 2011-169 and this transfer ordinance. Lone Star NGL Pipeline, LP further acknowledges and agrees that Grantor, City of Pasadena, Texas, possesses the jurisdictional and legal authority to issue this franchise to Grantee, Lone Star NGL Pipeline, LP. The City Secretary shall give written notice to the Director of Public Works and to the Legal Department upon acceptance of said franchise by Lone Star NGL Pipeline, LP, provided further that like notice be given upon Lone Star NGL Pipeline, LP's failure to accept within the time period heretofore identified.

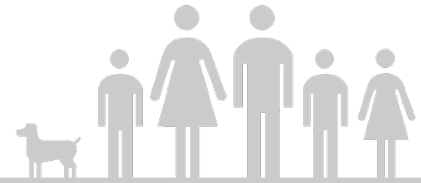

ing an interview in November, the immigration official focused on Barrientos' job with a state-licensed company that grows marijuana, he said.

Weeks later, he received a letter from U.S. Citizenship and Immigration Services denying him because of his job, his lawyers said.

"I was shocked, appalled, sad," Barrientos said. "It was a mixture of emotions. I had no idea I was going to be in this situation."

Barrientos' attorneys Aaron Elinoff and Bryce Downer, who specialize in immigration law in Colorado, said they also represent a woman whose citizenship application was denied because of a previous job at a marijuana dispensary. She asked not to be named publicly because of a new job in the medical field, they said.

"Frankly, these are the people we want to be citizens," Elinoff said. "And the U.S. government is telling them no. We don't know how many people have been denied on the same issue."

Kathy Brady, a senior staff attorney with the Immigrant Legal Resource Center, said legal immigrants have reported similar denials in Colorado and Washington state, where marijuana also is legal. Brady said she doesn't know how many people have been denied citizenship for their work in the marijuana industry.

She advises people without U.S. citizenship to find work elsewhere unless federal law changes.

"Even if you have had a green card for 20 years, you had better not work in any aspect of this industry and you better not use marijuana," Brady said.

Deborah Cannon, a spokeswoman for U.S. Citizenship and Immigration Services, said the agency does not comment on individual cases. She defended denials based on involvement with marijuana, saying the agency must follow federal law that prevents its use or sale.

"Despite state law that may allow medical marijuana use, the Supreme Court has held that Congress' authority under the Commerce Clause empowers it to prohibit drug distribution and possession, even if the prohibited activities are not also illegal under state law," she said. "When adjudicating applicants for citizenship, the agency is required to apply federal law."

A man named Charles Lee ran the United Nations Chinese Friendship Association and was photographed at least twice with Yang, who also goes by the name Yang Li. Yang previously owned a spa where New England Patriots owner Robert Kraft was charged with soliciting prostitution.

mothy was with others who would love and care for him. People magazine reported that she added a chilling message: "You will never find him."

Police said his mother took steps that suggested she might have dropped her son off with a friend, noting that the boy's car seat and Spider-Man backpack were gone. Police at the time also found credit card receipts showing she bought children's clothing and toys in Wisconsin.

Timothy's grandmother said Thursday that her daughter had fought depression for years and was having problems in her marriage to Timothy's father.

The father, Jim Pitzen, has since moved to Clinton, Iowa. Attempts to reach him by telephone for comment were unsuccessful.

At the time of the boy's disappearance, police searched for him in Illinois, Wisconsin and Iowa. The grandmother said the worst day was when blood was found in her daughter's car, but like all the other leads in the case, that one went nowhere.

Police in the Cincinnati suburb of Sharonville said the teenager calling himself Timmothy reported that he had escaped from two kidnappers he described as men with bodybuilder-type physiques. They were in a Ford SUV with Wisconsin license plates and had been staying at a Red Roof Inn, according to the police report.
