Dragon, which was launched by SpaceX on Saturday from Cape Canaveral, Florida. It also flew in 2017.

This is SpaceX's 17th delivery to the space station; the first was in 2012. Northrop Grumman is NASA's other shipper; its Cygnus cargo ship arrived just two weeks ago.

The Dragon will remain about a month, being filled with science samples for return to Earth. It's the only cargo ship capable of coming back intact.

Besides one Canadian, the space station is home to three Americans and two Russians.

one of the nation's lowest voter turnout rates — due, he says, to strict voter ID rules. O'Rourke also says jails are among Texas' top providers of mental health care and people deliberately get arrested to seek treatment. He says Texas is one of many places without laws prohibiting employers from firing people for being gay.

"It's a defense in a court of law in Texas if you've killed someone of the same sex because they came on to you in a bar or on the street," O'Rourke tells campaign audiences, noting that Texas and other states don't prohibit what LGBT activists call "gay panic defense" as a mitigating argument in criminal court.

Fellow Texan Julian Castro, ex-San Antonio mayor and Obama administration housing chief, is more critical of Trump than the Lone Star State, and praises his heavily Hispanic city.

"I came up in San Antonio that was almost 50-50 Republican/Democrat," Castro said, though politics there now are far more liberal. "I had to learn how to talk to the other side, consider their ideas, find common ground where we could."

Former Alaska Sen. Mike Gravel says he's running for president to push the field farther left — defying his home state, which hasn't voted Democratic for president since 1968.

is inherently more secure because the underlying code is easily scrutinized by outside security experts.

Two of the leading vendors, Election Systems & Software of Omaha, Nebraska, and Hart InterCivic of Austin, Texas, both expressed interest in partnering with Microsoft for ElectionGuard. A spokeswoman for a third vendor, Dominion Voting Systems of Denver, said the company looks forward to "learning more" about the initiative.

Anyone with an existing voting system or developing a new one will be able to incorporate the ElectionGuard development kit — at the state or local level in the U.S. or national level for jurisdictions abroad.

"It can be used with a ballot-marking device. It can be used with an optical scanner, on hand-marked paper ballots," said Josh Benaloh, a senior cryptographer at Microsoft Research and key contributor to the ElectionGuard project.

Benaloh helped produce a National Academies of Science report last year that called for an urgent overhaul of the rickety U.S. election system, which faced serious threats from Russian hackers who in 2016 attempted to infiltrate voting administration systems in several states.

That report called for all U.S. elections to be held on human-readable paper ballots by 2020. It also advocated a specific form of routine postelection audits intended to ensure that votes are accurately counted. While U.S. officials say there is no evidence of hackers tampering with election results, experts say systems used by millions of U.S. voters remain susceptible to tampering.

on July 2, 2008, while on the phone with two union delegates.

France Telecom, once a state-owned monopoly, transformed into a private company in the 2000s. Lombard launched a restructuring plan aimed at shedding 22,000 jobs, but most employees were still considered civil servants and so were protected from layoffs.

As it sought to reduce staff, the indictment says the company imposed "excessive and intrusive control" on employees, assigned workers to demoralizing tasks, failed to provide training, isolated staff and used "intimidation maneuvers or threats and pay cuts."

Presiding Judge Cecile Louis-Loyant said the court "wants to understand why some employees killed themselves, and why others tried to do so."

She noted that prosecutors believe "the repetition of cases was enough to characterize moral harassment, but does not accuse the defendants of causing the suicides. (The prosecution) holds that the method of personnel management affected various employees with an increase of psychological-social risk."

The judges agreed to include the complaints of the 126 employees who asked to join the case in the case file.
