President Donald Trump campaigned on a pledge to bring down America's persistent trade deficits. He imposed taxes on imports of steel, aluminum and most products from China, among other things; and renegotiated a North American trade pact in an effort to encourage more production in the United States.

But the trade deficit won't yield easily to changes in trade policy. As the U.S. economy recovers from springtime shutdowns, Americans are buying more imported goods while foreign demand for U.S. products remains weak.

In an unusual move, U.S. Trade Representative Robert Lighthizer issued a statement on the monthly trade deficit report Tuesday, defending the president's record. Lighthizer noted that the U.S. deficit in the trade of goods is down 2.4% so far this year and would have fallen more if it weren't for a surge in gold imports by investors using the precious metal to hedge against risks at a time of considerable uncertainty.

He also said: "The trade deficit increased in August because America's economy has recovered more quickly than our trade partners."

leave. At least 12,500 more took long-term leaves of absence.

Pay for union pilots, flight attendants, mechanics and ground workers are governed by long-term contracts, but Kelly wants "reasonable concessions" by Jan. 1.

Southwest brags that it has never laid off employees in its roughly 50-year history. The Dallas-based carrier — along with Delta Air Lines — convinced thousands of workers to take early retirement or buyouts but avoided layoffs or furloughs. In contrast, American Airlines and United Airlines furloughed 32,000 workers between them last week.

All the carriers are lobbying Congress and the White House for another \$25 billion in taxpayer money to pay workers for the next six months. That's on top of up to \$50 billion in cash and loans that Congress approved in March. Kelly said pay cuts would be rescinded if Congress approves more money.

RELIGIOUS RIGHTS: The day after the election in November, the high court will hear a dispute involving a Philadelphia Catholic agency that won't place foster children with same-sex couples. It's a big test of religious rights and could be one of the first cases the court hears with Barrett on board, if Republicans succeed in confirming her before the election.

The justices will review an appeals court ruling that upheld the city's decision to stop placing children with the Archdiocese of Philadelphia's agency because it would not permit same-sex couples to serve as foster parents.

The appeals court ruled that the city did not target the agency, Catholic Social Services, because of its religious beliefs, but acted only to enforce its own nondiscrimination policy in the face of what seemed to be a clear violation.

TECHNOLOGY: The most high-profile, big-dollar case the justices will hear arguments in this month is a copyright dispute between technology giants Oracle and Google.

The dispute has to do with Google's development of its Android operating system for smartphones. Oracle says that in developing the popular Android, Google copied approximately 11,500 lines of its copyrighted code. Google says it didn't do anything improper. Oracle disagrees and sued Google in 2010. It has said it's owed nearly \$9 billion.

Lower courts have grappled with the case for a decade. Most recently, after a jury sided with Google, an appeals court overturned that ruling.
