"We do expect the pace of sales to slow in the fourth quarter, with a weak recovery, resurgent pandemic and depleted inventories weighing on activity, although the risk may be for further upside surprises," said Nancy Van Housten, lead U.S. economist for Oxford Economics

The median price of an existing home was \$313,000, up 15.5% from a year earlier, mostly reflecting that the nationwide inventory of existing homes remains at or near record lows. The inventory of unsold homes sits at 2.5 months' supply, down from 2.7 months' supply in September.

site, along with credit card data from a client list that included Northrop Grumman, the Marine Corps and Time Warner Cable. They used some of the credit card numbers to donate money to the Red Cross, according to court records.

Federal prosecutors alleged the Stratfor hack resulted in more than a million dollars in losses to individuals and threatened public safety.

Hammond argued during his sentencing the hacks were civil disobedience to expose the pervasiveness of government and private surveillance.

During a 2014 interview with The Associated Press, Hammond laughed at the idea that some consider such attacks as threatening to national security as terrorism.

"I mean, I didn't kill anybody," he said.

Hammond last year was summoned to testify to a federal grand jury in Virginia. He was found guilty of civil contempt after he refused to testify.

Raised in the Chicago suburb of Glendale Heights, Hammond described himself as a "nonconformist, anti-authority" kid who at 8, tried to design video games. A few years later, he started hacking.

He started the University of Illinois at Chicago with a full scholarship, but was kicked out after hacking into the university's computer science department website and telling administrators about the vulnerability.

Over the years, his supporters have elevated him to near-mythical status on the internet and have sold buttons, t-shirts and other merchandise bearing his name and picture. In a Tuesday tweet, the Jeremy Hammond Support Committee expressed joy that Hammond had been released from prison.

Moser also said that he believed HomeyTel had been out of business for years and used its information because his client wished to remain anonymous.

Moser says he doesn't believe the fine can be enforced without the FCC referring the case to the U.S. Department of Justice.

"However I doubt they would want to touch a political prosecution like this about purportedly harming either a defunct corporation or voters by transmitting someone's political message not of my making," Moser wrote.

"Your cooperation determines our fate," Koike said. "The key is not to have serious cases and that's the red line."

Prime Minister Suga, meanwhile, instructed Cabinet ministers to do their utmost to tamp down on infections, but he said his government's tourism and dining incentives will continue, including the "GoTo eat" campaign that subsidizes dining out.

Groups dining out should be limited to four people, Suga said. He also asked people to wear masks when dining, removing them only when they put food in their mouths and immediately put them back on.

"I ask the people to quietly dine with masks," Suga said. "I will start thoroughly doing that myself."

As elsewhere, infections have gradually climbed back in Japan as the government tries to balance limiting the spread of the disease while avoiding too much damage to the economy with restrictions on business activity.

A top government panel expert, Shigeru Omi, warned a parliamentary session Wednesday that groups of infections are now occurring in a variety of situations, making preventive measures more challenging and requiring the scaling down of economic and social activity.

"It's time to buckle up again," Omi said.

Japan Medical Association President Toshio Nakagawa urged Tokyo residents to stay home over the weekend.

Economy Revitalization Minister Yasutoshi Nishimura has said that groups in the service industry are revising their safety guidelines to step up preventive measures at restaurants and bars where risks are deemed high.
