In 1996, Plaintiff attempted to sell his business. At that time, it was discovered that the third party no longer held a valid leasehold interest and did not own the property. Plaintiff continued to pay all real property taxes due on the property. Plaintiff attempted to contact the Campas without success. The Campas have never contacted Plaintiff

Plaintiff now desires to sell the business. Plaintiff hired an investigator to locate the Campas or their heirs. No living heirs were identified. Joanna Campa dies in 1992. James Campa died in 2002. There is no evidence of a probate action in the name of James or Joanna Campa in either Harris County, Texas or Angelina County, Texas, the only known residences of James and Joanna Campa. The Court appointed an attorney ad litem to represent the unknown heirs of Campa, but that attorney has not been able to locate any living heirs of James or Joanna Campa.

vices, said Tuesday that he could not provide lawmakers with the number of people tested for the virus in the state. Texas Gov. Greg Abbott has also asked health insurers to waive costs related to diagnosing the virus for families who are on state-regulated insurance plans.

A dozen cases around Houston have all been related to travelers on an Egyptian cruise. Lackland Air Force Base in San Antonio has also received passengers from cruise ships and American evacuees from Wuhan, China.

Collin County officials said the father was in his 30s and is believed to have been exposed to the virus during a trip to Silicon Valley in February. The county said the family's children had no symptoms and were not contagious while attending school.

In Austin, the MotoGP racing series on Tuesday postponed the annual Grand Prix of the Americas that was scheduled for April until Nov. 15. Local organizers said MotoGP's decision was based on global travel considerations and noted that many of the race teams are based in Italy.

"The risk of shipping everything here, having fans coming here, and then not having an event, that was too big a risk to take," said Bobby Epstein, chairman of the Circuit of the Americas race track where the grand prix is held.

a struggle in the apartment where Durst had gone to hide out after Berman was killed.

Durst was acquitted, which DeGuerin frequently emphasized for jurors. He said that in the current trial, that dismemberment is "the elephant in the room" that is overwhelming all the other evidence.

"The jury in Galveston was able to separate the manner in which Morris Black died from what happened to his body after he was dead," Deguerin said. "The evidence will show that what happened to his body, the dismemberment, could not change the manner in which he died. No matter how gruesome."

The prosecution, whose three-day opening statement ended Monday, is being permitted to allege in this case that Durst deliberately killed Black because Black had learned that Durst, who was disguising himself as a woman, was in fact a wealthy real estate heir who was on the run.

The prosecution is also allowed to allege that Durst killed his wife Kathie, whose 1982 disappearance has brought him decades of suspicion and media attention. Durst denies having anything to do with the New York disappearance of his wife, who has since been declared dead despite no body being found.

DeGuerin said that living with that suspicion, along with mild autism that makes social life difficult for him and a tendency to self-medicate with marijuana and alcohol.

race, declare whether they're Hispanic or not, and provide details about their country of origin. All other residents in the household must answer, or have the first form-filler answer for them, the same questions on age, sex, race and Hispanic origin. They must specify their relationship to the form-filler and if they live elsewhere, like away at college. For the first time, same-sex couples will be able to identify as such, either as spouses or unmarried partners.

IS THERE A CITIZENSHIP QUESTION?

No. The Trump administration tried to add the question, but the U.S. Supreme Court blocked it.

WHAT IF I DON'T SPEAK ENGLISH?

Besides English, respondents will be able to answer the census questionnaire in Spanish, Simplified Chinese, Traditional Chinese, Vietnamese, Korean, Russian, Arabic, Tagalog, Polish, French, Haitian Creole, Portuguese and Japanese. Guides in both video and print are being issued in 59 languages, including American Sign Language.

WHO GETS COUNTED?

Everyone residing in the United States and the five U.S. territories, including non-citizens and immigrants living in the country illegally. Prisoners are counted in the facilities where they live, and military personnel temporarily deployed overseas are counted at their home addresses in the U.S.
