Continued from front page water systems not following regulations back in line.

The committee came after Edwards in December 2016 declared a public health emergency in the small northeast Louisiana town of St. Joseph and urged people not to use the water coming out of their taps because the state found elevated levels of lead and copper in the system.

The state trucked in water to residents while \$8.6 million went into a new water treatment and distribution plant for St. Joseph. In March 2018, Edwards lifted the public health emergency.

St. Joseph's water troubles were a warning about the risks of aging infrastructure, particularly in rural communities that no longer have the financial abilities to maintain the systems.

The state's problems are extensive, according to an infrastructure report card issued by the American Society of Civil Engineers. The organization's latest assessment in 2017 gave Louisiana a D-minus grade for its drinking water, similar to the prior report card issued five years earlier.

"Louisiana's drinking water infrastructure is aging, and little is being done to replace or upgrade many of the current systems in place," the engineers said in the report.

In a survey released a year later, the U.S. Environmental Protection Agency estimated Louisiana's 20-year funding needs for drinking water infrastructure topped \$7 billion.

Hurricane Laura's destruction emphasized how important basic infrastructure, such as a functioning water system, is to home and businesses. It also may force some of the most heavily damaged systems to build stronger to meet updated regulations, while administrators of other water systems may simply find it wise to harden their infrastructure.

Ames said she hoped "if they did have issues that were directly correlated to failing infrastructure or old infrastructure, that they would take it upon themselves to try to bring their system into a newer day."

Continued from front page companies to add women in particular to their boards. California, for example, requires companies that are headquartered in the state and whose stock is publicly held to have at least one woman on their board.

One reason is that investors and others say it's easier to track the numbers on gender diversity than on racial or ethnic diversity. But The Board Challenge is the latest example of the pressure moving toward better representation for racial minorities as well.

State Street Global Advisors, which is a major shareholder in more than 10,000 companies around the world through its funds, late last month sent a letter to companies asking them to offer details about the racial diversity in their boardrooms and workforces, for example. State Street is the company that commissioned the "Fearless Girl" statue that faced down Wall Street's famous "Charging Bull" statue.

Shareholders have been increasing pressure on businesses to improve their diversity, an effort that may have reached a tipping point this year, according to analysts at Morgan Stanley. They found that 20% of diversity-related proposals at annual shareholder meetings passed this year, as of early August. That's up from zero just two years ago.

The 17 companies that pledged to add a Black director in the next 12 months are Accolade, Altimeter Growth, Amperity, Bolster, Gusto, Heritage-Crystal Clean., Heritage Environmental Services, HopSkipDrive, Kin, M.M.LaFleur, Nextdoor, PagerDuty, RealSelf, Ripple, Senreve, Vinyl Me, Please and Zillow.

Continued from front page com giant Huawei, Shenzhen-based DJI was already under close watch as a potential national security threat.

A document from U.S. customs authorities alleged in 2017 that DJI drones likely provided China with access to U.S. critical infrastructure and law enforcement data. DJI denied the allegation. As political concerns grew, its rivals have increasingly seized on the opportunity to pile on the anti-DJI sentiment.

"Do you trust DJI drones?" said promotional material teasing the launch of a new product this summer from French drone-maker Parrot. "Don't trust Chinese drones," said another Parrot promotion.

"They're the dominant incumbent and we're the scrappy American underdog," Skydio CEO Adam Bry said in an interview. "There's a real opportunity for U.S. companies to lead the way."
