In The Interest Of Ja'ier Ghanem A Child In The District Court 507th Judicial District Harris County, Texas Order For Genetic Testing

On October 7, 2021, the Court heard the Motion for Genetic Testing of Ja'ier Ghanem. The Court finds that it is medically practical to take blood, buccal cells, bone, hair, or other body tissue or fluid samples for genetic testing and that genetic testing has been requested and is required by section 160.502 of the Texas Family Code.

It Is Therefore Ordered

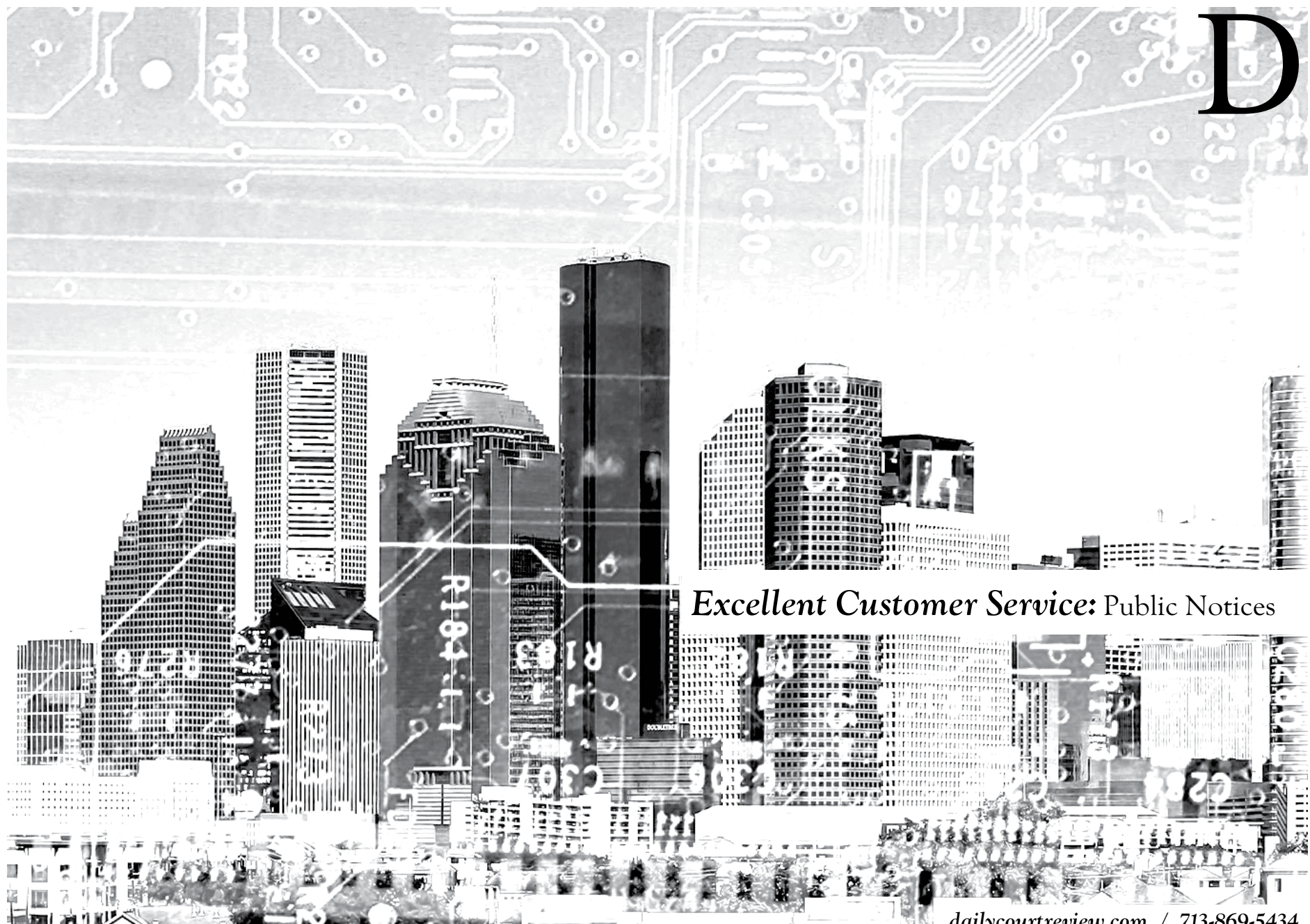

Dawn Crawley, CEO of House Cleaning Heroes, a cleaning service based in Herndon, Virginia, said she had to cancel four of 20 cleaning jobs for Tuesday because four employees were sick – three with COVID-19.

"The fear is it will run through the team" as well as customers, she said.

Policymakers and health authorities have been mindful of the toll on the economy and the education system.

Public health experts have said that eradicating the virus is unlikely and that the world will instead have to find a way to keep COVID-19 down to an acceptable level, the way it does with the flu.

Last week, after the Centers for Disease Control and Prevention cut the recommended COVID-19 isolation period from 10 days to five, CDC Director Dr. Rochelle Walensky said: "We want to make sure there is a mechanism by which we can safely continue to keep society functioning while following the science."

In another development Monday that could have a bearing on the ability of schools to stay open, the Food and Drug Administration gave its OK for Pfizer booster shots for children as young as 12. Boosters already are recommended for everyone 16 and older.

known as "fake it 'til you make it." That ethos helped hatch groundbreaking companies such as Google, Netflix, Facebook, and Apple – the latter co-founded by one of Holmes' heroes, Steve Jobs.

Her conviction might lower the wattage – at least temporarily – on the brash promises and bold exaggerations that have become a routine part of the tech industry's innovation hustle.

The trial's outcome "will send a message to CEOs that there are consequences in overstepping the bounds," predicted Ellen Kreitzberg, a Santa Clara University law professor who attended the trial. But she also believes greed will keep hyperbole alive in Silicon Valley.

"Investors are still going to want to make more money on a promising idea," Kreitzberg said. "They will always go in for the golden ring."

Holmes remained seated and expressed no visible emotion as the verdicts were read. She bowed her head several times before the jury was polled by U.S. District Judge Edward Davila. After the judge left the courtroom to meet with jurors individually, Holmes got up to hug her partner, Billy Evans, and her parents before leaving with her lawyers.

During a brief break after the verdict read, a visibly shaken Evans stepped into the courthouse hallway to get a get drink from a water fountain while apparently trying to compose himself.

Holmes did not respond to questions about the verdicts lobbed at her during a three-block walk from the courthouse to the nearby hotel where she has stayed during jury deliberations.

department to dig up and remove specific types and amounts of radioactive and hazardous material.

The agency said it removed about 13,500 cubic yards (10,300 cubic meters) of material – which is the equivalent of nearly 50,000 storage drums each containing 55 gallons (208 liters).

Most of the waste is being sent to the U.S. government's Waste Isolation Pilot Plant in New Mexico for permanent disposal. Some waste will be sent to other off-site repositories that could be commercial or Energy Department sites.

The Energy Department said it is 18 months ahead of schedule in its cleanup of the landfill.

"The buried waste was the primary concern of our stakeholders since the beginning of the cleanup program," Connie Flohr, manager of the Idaho Cleanup Project for the Energy Department's Office of Environmental Management, said in a statement. "Completing exhumation early will allow us to get an earlier start on construction of the final cover."

ship of MCC and the Bureau of Prisons."

Foy said Noel now faces administrative proceedings with the Bureau of Prisons.

A lawyer for Michael Thomas did not immediately comment.

Epstein's death sparked widespread anger that he wouldn't have to answer for the allegations. Last week, his former girlfriend, Ghislaine Maxwell, was convicted in Manhattan federal court of sex trafficking and conspiracy charges after a month-long trial.
