City Ordinances

ORDINANCE NO. 2022-166

An Ordinance authorizing and approving transfer to Easton Energy of pipeline franchise for one (1) 4" Ethylene pipeline granted by Ordinance No. 2020-153 to Easton Energy Pipelines LLC; providing a savings clause; and providing for severability.

WHEREAS, Equistar Chemicals, LP has requested approval of a transfer of one (1) 4" Ethylene pipelines to Easton Energy Pipelines, LLC of pipeline franchise granted by Ordinance No. 2012-128 to Equistar Chemicals, LP (see Exhibit "1" attached hereto and incorporated herein for all purposes); and WHEREAS, Easton Energy Pipelines, LLC has paid the appropriate transfer fee; and WHEREAS, the Director of Public Works has recommended such transfer and requested this ordinance; and WHEREAS, the Director of Planning has recommended such transfer; NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PASADENA:

SECTION 1. That the pipeline franchise granted through Ordinance No. 2020-153 is hereby transferred to Easton Energy Pipelines, LLC. The mailing address and phone number for Easton Energy Pipelines, LLC is Easton Energy Pipelines, LLC, Attn: Land Dept., Ross Dillon, Chief Operating Officer, 15375 Memorial Dr., Ste 850, Houston, Texas 77079, Cell: 210-792-0268, email: rdillon@eastonenergy.com.

SECTION 2. That the approval of this transfer is contingent upon the application of all terms and conditions of present day pipeline franchise ordinances to this ordinance.

SECTION 3. Easton Energy Pipelines, LLC shall, as a condition of this franchise, at all times by separate instrument keep the City apprised of valid and functioning emergency and non-emergency address and telephone number(s) by which the City may contact the Grantee when necessary. Such contact information shall be kept current and updated by Grantee in writing sent to the following:

Fire Chief, P. O. Box 672 Pasadena, Texas 77501, (713) 475-5554

Such notice shall be made within a reasonable time after the pipeline transfer, company name change or other event causing such change but, in no event shall notification to City be more than thirty (30) days after the event causing the change has occurred. Failure to timely apprise City as required by this section shall result, upon approval by the City Council of the City of Pasadena, Texas, in a penalty of \$100 per day for every day the notification is past thirty (30) days after the event causing the change has occurred.

SECTION 4. That Easton Energy Pipelines, LLC shall file its written acceptance of this franchise, a facsimile of which is attached hereto as Exhibit "2", with the City Secretary of the City of Pasadena within thirty (30) days from the date of passage hereof, and shall thereupon be bound by all of the terms and conditions of franchise agreement under Ordinance No. 2012-128 and, renewal Ordinance No. 2020-153 and this transfer ordinance. Easton Energy Pipelines, LLC further acknowledges and agrees that Grantor, City of Pasadena, Texas, possesses the jurisdictional and legal authority to issue this franchise to Grantee, Easton Energy Pipelines, LLC. The City Secretary shall give written notice to the Director of Public Works and to the Legal Department upon acceptance of said franchise by Easton Energy Pipelines, LLC, provided further that like notice be given upon Easton Energy Pipelines, LLC failure to accept within the time period heretofore identified.

SECTION 5. That all rights and remedies which have accrued in favor of the City under said Ordinance Nos. 2012-128 and 2020-153 shall be and are preserved for the benefit of the City.

SECTION 6. That the City Council of the City of Pasadena, Texas, does hereby declare that if any section, subsection, paragraph, sentence, clause, phrase, word or portion of this Ordinance is declared invalid, or unconstitutional by a court of competent jurisdiction that in such event it would have passed and ordained any and all remaining portions of this Ordinance without the inclusion of that portion or portions which may be so found to be unconstitutional or invalid, and declares that its intent is to make no portion of this Ordinance dependent upon the validity of any other portion thereof, and that all said remaining portions shall continue in full force and effect.

SECTION 7. That pursuant to the requirements of House Bill 1295, 85th Legislative Session, this contract is contingent upon the business entity's completion of the required Form 1295, Certificate of Interested Parties, if applicable.

SECTION 8. That the City Council officially determines that a sufficient written notice of the date, hour, place and subject of this meeting of the City Council was posted at a place convenient to the public at the City Hall of the City for the time required by law preceding this meeting, as required by the Open Meetings Law, Chapter 551, Texas Government Code; and that this meeting has been open to the public as required by law at all times during which this ordinance and the subject matter thereof has been discussed, considered and formally acted upon. The City Council further confirms such written notice and the contents and posting thereof.

in a diversion program that would require mental health or substance abuse treatment in lieu of jail time.

Denver, Colorado, and Austin, Texas, have also passed ordinances both banning public camping and allowing sanctioned campsites. Denver has opened several "safe outdoor spaces" since 2020 where tents, food and other services are provided. In Austin, the Esperanza community is a sanctioned encampment that serves about 150 people and is currently constructing 200 individual shelter units.

The Cicero Institute, which wrote the model legislation that inspired many of the recent camping ban policies, says creating specific areas where camping is permitted can be a faster solution for cities compared to building affordable housing.

"One of the biggest problems that sanctioned camping is trying to address is just the unbelievable difficulty of getting more shovels in the ground to get shelter or other sorts of services available for the homeless," said Judge Glock, the group's senior director of policy and research.

THREATS FROM WITHIN

Insider threats are a growing concern and could undermine serious strides made to secure voting systems — including migrating to hand-marked paper ballots and introducing reliable audits — since they were declared critical national infrastructure in January 2017.

Rogue election officials could provide access to voting systems to unauthorized individuals, as happened in Colorado and Georgia. Poll workers or even voters could try to access voter registration databases or equipment, or plant malware to taint election management systems.

Eddie Perez, a voting technology expert with the nonprofit OSET Institute, calls the repeated efforts to cast doubt on the integrity of voting equipment an element of a more broad "manufactured chaos" — intentional subversion of the nation's elections to sow doubt.

Perez is among specialists who think attempts to discredit voting technology are one manifestation of efforts by former President Donald Trump and his allies to undermine trust in election results so Republican-controlled state legislatures — rather than voters — can decide the outcome of future races.

To counter the threats from insiders, federal authorities have conducted trainings and encouraged election officials to focus on limiting access to critical equipment, adding video surveillance and key cards on doors. They also encourage strict chain-of-custody rules for everything from ballots to voting scanners and tabulators.

Threats to public officials and election disruption attempts have occurred with increasing frequency and intensity, federal and local law enforcement officials say. They are especially concerned about physical violence by protesters in highly contested districts during the post-election vote-counting process.

Islam's Prophet Muhammad was born around 570 and died in 632 after conquering Mecca in present-day Saudi Arabia.

Viewed from above, the monastery on Siniyah Island's floor plan suggests early Christian worshippers prayed within a single-aisle church at the monastery. Rooms within appear to hold a baptismal font, as well as an oven for baking bread or wafers for communion rites. A nave also likely held an altar and an installation for communion wine.

Next to the monastery sits a second building with four rooms, likely around a courtyard — possibly the home of an abbot or even a bishop in the early church.

On Thursday, the site saw a visit from Noura bint Mohammed al-Kaabi, the country's culture and youth minister, as well as Sheikh Majid bin Saud Al Mualla, the chairman of the Umm al-Quwain's Tourism and Archaeology Department and a son of the emirate's ruler.

The island remains part of the ruling family's holdings, protecting the land for years to allow the historical sites to be found as much of the UAE has rapidly developed.

The UAE's Culture Ministry has sponsored the dig in part, which continues at the site. Just hundreds of meters (yards) away from the church, a collection of buildings that archaeologists believe belongs to a pre-Islamic village sit.
