tion running at a 40-year peak and the Federal Reserve's efforts to reduce price pressures.

It is unclear if greater fiscal responsibility can deliver politically for Biden as Democrats try to defend control of Congress. His two most recent Democratic predecessors, Bill Clinton and Barack Obama, also cut budget deficits, only to leave office and see their Republican successors use the savings on tax cuts.

Still, Biden hopes to draw a sharp contrast with former President Donald Trump, whom he beat in 2020. Trump, among a multitude of promises, pledged to lower the national debt yet failed to do so during any financial quarter of his presidency. Biden has repeatedly taken aim at that broken promise.

Earlier this week, Treasury said that it expects to pay down \$26 billion in privately held debt from the April to June quarter this year. However, the hope to reduce the debt may be dampened by Treasury's expectation to borrow \$182 billion in privately held debt from July to September.

When unveiling his budget plan in March, Biden said that after his Republican predecessor's "fiscal mismanagement" his administration is "reducing the Trump deficits and returning our fiscal house to order."

One of the challenges for Biden is that voters have largely shrugged off deficit increases and seldom rewarded deficit cuts. Voters might discuss the idea of reducing deficits with pollsters, yet health care, incomes and inflation are often top of mind when casting their ballots.

Norman Ornstein, an emeritus scholar at the conservative American Enterprise Institute, noted that deficits are often "abstract" for voters. The recent low interest rates have also muted any potential economic drags from higher deficits, which have risen following the COVID-19 pandemic and, separately, the 2008 financial crisis, to help the economy recover.

"They're more likely to respond to things that are in their wheelhouse or that they believe will have a more direct effect on their lives," Ornstein said. Deficits are "a step removed for most voters, and we've been through periods where we've had the big deficits and debt and it's not like it devastated directly people's lives."

ing and Jackson had no history of violence.

"It is a textbook example of how innocent people get convicted," said Justin Keiter, another of Jackson's attorneys.

Jackson said in a YouTube video posted in May 2019: "I am not Josue's killer. I am not a killer."

The Marine Corps veteran was first arrested weeks after Josue's killing. But prosecutors dropped the charge in 2017, saying there wasn't enough evidence to try Jackson or uphold a conviction.

He was rearrested in 2019 after prosecutors said newly tested DNA evidence connected him to the killing.

Jackson wasn't the first person charged in the case.

A 31-year-old man with a long criminal history was charged days after the killing, but that charge was dropped when detectives found evidence to support his alibi.

contact with coyotes.

A report Timm co-authored for the Fall 2017 edition of the journal Human-Wildlife Interactions cited a 2009 study that tabulated 142 reported coyote attacks on humans in the United States and Canada over almost a half-century from 1960 to 2006. A 2011 study recorded 26 coyote attacks on humans in Canada between 1995-2010.

"This is a difficult problem to manage, given the diversity of public attitudes toward coyotes, especially in suburban areas," he said in an email to The Associated Press. "It quickly becomes a political nightmare for cities, counties, and public agencies, as many people oppose any lethal control of wildlife, which at times is the only solution when some individual coyotes become habituated to living in suburbia to the extent that they attack pets and humans."

Montgomery march led by the Rev. Martin Luther King Jr.

Maxwell is part of a group of Brown Chapel members serving on a foundation that's trying to raise money for repairs estimated to exceed \$4 million, she said. The church, located in a public housing community, has only a few dozen members in regular attendance, so it's relying on grants and outside donations to fund the work.

The National Park Service already has provided a grant of \$1.3 million for restoration of the church, which was constructed in 1908 by a formerly enslaved Black builder, A.J. Farley, and declared a National Historic Landmark in 1997.
