expenses not only hurt businesses' bottom lines, but also affect how well they can retain and attract workers. Before the pandemic, Hughes would get hundreds of applicants for openings. Now, she says she's lucky to get one or two, and they tend to want \$18 or \$20 an hour, when she offers \$14 or \$15 for experienced bakers.

Hughes has had to add benefits for her two long-time staffers to hang onto them.

Teresa Depola is also taking on more work herself because of a lack of available help. She opened Betty Boops Diner in Albany, New York, 10 years ago, with her husband and son, and kept running it after she and her husband divorced.

While she ideally would have three staffers to run the place, lately she's been a one-person workforce: cooking, waitressing, and even running deliveries.

"It's small enough so I can do it myself, it's not bad," she said. Still, she would like to add some staff so she could serve dinner again. She's been serving breakfast and lunch only and closing at 3 p.m. since the pandemic started. And she doesn't see the job picture improving anytime soon.

"I don't think it's going to change for a while," she said. "I'm going to keep it the way it is right now, people are not willing to work just yet. I'm still having a lot of trouble finding staff."

While most major U.S. industries have regained the jobs lost to the pandemic, employment in leisure and hospitality is down by 1.5 million, or 8.7%, since February 2020, according to the Bureau of Labor Statistics.

Many in the industry faced burnout after being on the front lines during two years of the COVID-19 pandemic, said Rob Wilson, president of human resources provider Employco. Some who stayed in the industry switched to larger restaurants where wages might be higher. Others left and looked into new opportunities.

"There's nobody to hire, there's nobody out there looking for jobs," said Anesh Bodasing, who opened Tiffin Box, a fast-casual Indian restaurant in West Palm Beach, Florida, in 2019 with 20 staffers.

mortgages and small-business loans in their communities but is murky about what other types of loans or activities can count as community reinvestment.

"It has been 27 years since the government made a meaningful effort to keep Community Reinvestment Act rules up to date with the convulsions of technology, financial industry consolidation and other key changes to how Americans work and live," said Jesse Van Tol, president of the National Community Reinvestment Coalition, an umbrella group for local groups who use CRA to push banks to do more types of low-income lending.

"We've seen how much harm such lags can do as economic chasms of race and class have persisted and even expanded," he said in a statement.

While banks and community groups agreed an overhaul was needed, the three bank regulators were unable to agree on how to overhaul the regulations. Under the Trump administration, the Comptroller of the Currency made its own proposal on how to rewrite the CRA. The proposal was not accepted by the Fed or FDIC, and was scrapped in the early days of the Biden administration.

million lower in the 2020 Census than 10 years ago, while this age group increased by more than 400,000 in Texas.

A variety of actions can help. Greater use of technology is part of the solution, as is encouraging people back to work through better compensation and other benefits. Companies can also make it easier for workers by offering childcare and parent care, more flexibility, remote work options, and other enticements. Immigration has long been a crucial source of labor, and reform can help speed the flow of the needed workers. Programs to improve adult literacy can help now, and improved public educational outcomes are essential going forward.

Texas has a robust economy and bountiful opportunities. Nonetheless, it is an inescapable fact that worker shortages are going to be with us for a while. Stay safe!
