location in Texas, possibly in one of three nearby cities, including Galveston, in order to attract more visitors and increase revenue.

Moving the ship for repairs is "the major step in getting the ship back to tip top shape," Gregory said Tuesday as he stood on the vessel while workers made final preparations.

The battleship will be pulled by four tugboats at a pace of about 5 knots per hour. The 40-mile journey to Galveston was expected to take about nine hours and won't be without risk as the ship's hull could leak enough to sink it.

"Once we get going, I anticipate it being pretty smooth... We feel like we're prepared," Gregory said.

Since 1948, the USS Texas has been located at the state historic site where the decisive battle in the Texas Revolution was fought. There, it's served as a museum and tourist attraction. The battleship was previously taken to the same shipyard in Galveston for repairs in 1988.

For the last three years, the ship has been closed to the public as the foundation has been preparing for the repairs. In 2019, the Texas Legislature approved the \$35 million to fix the hull. The foundation is planning to make other fixes which it's paying for. All the repairs are expected to take up to a year to complete.

The foundation expected many people to gather along the ship channel to watch the ship go by.

Tricia Thomas, 50, who was one of the people invited to watch as the ship was unmoored, said she became emotional and teared up as she saw the ship move and heard its whistle sound as it began its journey. As the ship began moving, Thomas said, people clapped and cheered.

"It's amazing to see a ship that's 100 years old out on the water again, moving like she did for so many years. It was exciting," said Thomas, who lives in the Houston suburb of Kingwood.

Thomas said she believes it's important to preserve the ship so future generations can learn its history and it can remind people how they can come together for a common cause that's greater than them.

"I think that's probably the biggest story she can tell," Thomas said.

released some body camera footage from Uvalde police that show officers from multiple agencies in and outside the school during the attack.

The fullest account of the shooting has so far come from a report from a Texas House investigative committee that found wide failures by nearly 400 officers who rushed to the scene but waited more than an hour to confront the gunman. The report, released in July, also noted that Uvalde families had "already waited too long for answers and transparency."

The Texas Department of Public Safety, which had more than 90 officers at the scene, has also denied public records requests since the shooting.

Friday, tweeting, "We're not dumping a bunch of shipping containers in the desert and calling it a wall to get cheap press." Ducey retorted that "we've taken matters into our own hands" because the federal government hasn't done enough.

Migrants continue to avoid barriers by going around them — in this case, through a 5-mile gap in the Cocopah Indian Reservation near Yuma, a desert city of about 100,000 people between San Diego and Phoenix that has become a major spot for illegal crossings.

President Joe Biden halted wall construction his first day in office, leaving billions of dollars of work unfinished but still under contract. Trump worked feverishly in his final months to reach more than 450 miles, nearly one-fourth of the entire border.

Highhouse recommended a seven-year prison sentence, writing that Highhouse characterized his abuse as an "inappropriate relationship" and blamed his conduct on marital problems.

All sexual activity between a prison worker and an inmate is illegal. Correctional employees enjoy substantial power over inmates, controlling every aspect of their lives from mealtime to lights out, and there is no scenario in which an inmate can give consent.

Earlier this year, an Associated Press investigation revealed years of sexual misconduct at FCI Dublin, including allegations against the prison's former warden. The AP also detailed steps that were taken to keep abuse secret, such as ignoring allegations, retaliating against whistleblowers and sending prisoners to solitary confinement or other prisons for reporting abuse.
