key role in propelling the economy, will endure.

The immigration boom was a surprise. In 2019, the Congressional Budget Office had estimated that net immigration – arrivals minus departures – would equal about 1 million in 2023. The actual number, the CBO said in a January update, was 3.3 million.

Thousands of employers desperately needed the new arrivals. The number of native-born Americans in their prime working years – ages 25 to 54 – was dropping because so many of them had aged out of that category and were nearing or entering retirement. Their numbers have shrunk by 770,000 since February 2020, just before COVID-19 slammed the economy.

Precision

New AI technology promises precision in the field. Erickson backs this claim up. With the accuracy of this technology, the days of planes or tractors spraying chemicals seem to be coming to a swift end. Additionally, farmers can use fewer chemicals to treat a field since the drone flies directly over the crop and has a directed spray, which leads to little to no chemical drift and loss.

Reduced Maintenance Costs

Aside from the lower initial investment and fewer costly tractor repairs, farmers will pay less to maintain drones. Due to improved coverage, the cost of chemicals and fertilizers is lower, and there is less need for expensive tractors, equipment, and labor.

Environmental Impact

Several factors make drones a favorable option. The hardware consumes a fraction of the fuel that a tractor uses. The drones are battery-operated, relying on in-field generators for charges.

Because of the precise nature of application, maintaining a crop's health requires fewer harmful chemicals.

The UAVs can perform multiple tasks. At present, they spray and fertilize with liquids. There are also spreader attachments to distribute seeds, granular fertilizers, or chemicals.

Soon, such drones will be able to "scout" farms and orchards to determine any potential treatments needed to maintain crop health. Erickson says this process is currently being developed with smaller drones.

job," said Sarah Damaske, who studies labor and employment relations, and sociology at Penn State. "I think it makes it less risky to do something like go and be a content creator because employment with a traditional employer is so much riskier."

In an estimated \$250 billion industry, 4% of global content creators pull in more than \$100,000 annually, according to Goldman Sachs Research. YouTube – considered by creators to be one of the more lucrative platforms – has more than 3 million channels in its YouTube Partner Program, which is how creators earn money. A spokesperson said the platform paid out more than \$70 billion in the last three years.

Meanwhile, TikTok – which faces the threat of a national ban that could cost many creators an income stream – has seen a 15% growth in user monetization, according to a company spokesperson.

Many people turn to full-time content creation only after they've seen a payoff from putting in the work, said Brooke Erin Duffy, a professor of communication at Cornell University. Or they are forced into it, as an avenue back to employment.

The pandemic also reshaped how employees consider work, with many preferring to have more control over their schedules and the ability to do their jobs from home. In February, nearly 440,000 people applied to start their own businesses – up nearly 50% from a monthly pace of 300,000 just before the pandemic, according to the U.S. Census Bureau.

to addressing the many challenges emanating from the pandemic. At present, it appears as if the elusive soft landing may have already been achieved, though future events could certainly cause disruptions.

The Perryman Group's latest projections indicate increases in US real gross domestic product at a 2.65% annual pace over the 2023-2028 period. Total employment is projected to grow by approximately 13.9 million net new positions, an annual increase of 1.72%. Performance will likely be below these thresholds in 2024, with momentum building over time.

Uncertainty will remain high due to the situations in the Middle East, Ukraine, Venezuela, the Red Sea, and elsewhere. A major escalation could lead to higher energy prices, supply chain disruptions, and other potential headwinds. We also must confront the quadrennial gyrations of election year politics. Nonetheless, the economy is on much more solid ground than in the not-too-distant past, and the underlying fundamentals sustain moderate expansion. Stay safe!
