tatives this year, according to an Associated Press analysis using the legislation-tracking software Plural. Meanwhile, Democrats have sponsored measures supporting DEI in at least 20 states.

Last month, the flagship University of Texas campus in Austin — one of the largest campuses in the U.S. — announced the closure of the school's Division of Campus and Community Engagement and the elimination of jobs in order to comply with the ban.

Earlier this year, the University of Florida announced more than a dozen terminations in response to a similar state ban.

Texas A&M University System Chancellor John Sharp told lawmakers the legislation "makes it crystal clear" that "if you tread back into the bad waters, something bad is going to happen to you."

On Monday, the University of North Carolina at Chapel Hill Board of Trustees approved diverting \$2.3 million of state funds for advancing diversity to instead serve public safety and policing. The move comes as North Carolina's public university system will consider changing its diversity policy before the legislature steps in.

In Oklahoma, the head of the University of Oklahoma's Carl Albert Congressional Research and Studies Center announced earlier this month that he was forced to terminate its National Education for Women Leadership program because of an anti-DEI executive order signed by Republican Gov. Kevin Stitt last year. The program trained more than 650 women from dozens of colleges and universities across the country over the past 20 years.

panel discussion in Amsterdam, Powell acknowledged that his confidence in that forecast has weakened after three straight months of elevated price readings. Inflation has fallen sharply from 9.1% in the summer of 2022 but is higher now than in June 2023, when it first touched 3%.

The Fed's policymakers have raised their key interest rate to a 23-year high of 5.3% in an effort to quell rising prices. Powell underscored Tuesday that the Fed will keep its rate at that level for as long as needed to fully conquer inflation, a signal that rate cuts won't begin as soon as many people had hoped.

the devastated areas in Agam, Tanah Datar, Padang Panjang, Padang Pariaman as well as Padang city, the provincial capital.

The method is known as cloud seeding and creates precipitation, thereby modifying weather.

Indonesia's air force teamed up with the country's technology agency to carry out three rounds of cloud seeding on Wednesday, Karnawati said, adding that more would take place as needed. About 15 tons of salt have been prepared for Wednesday's action.

Indonesia's technology agency, known as BPPT, said in a statement that all rain clouds moving towards the four West Sumatra's districts will be shot with sodium chloride, or salt.

effects on white children.

For a brief period, it seemed the country recognized the deeper remedies required. "All things being equal, with no history of discrimination, it might well be desirable to assign pupils to schools nearest their homes," Chief Justice Warren Burger wrote in *Swann v. Mecklenburg*, a 1971 decision that upheld the use of busing to integrate schools in North Carolina. "But all things are not equal in a system that has been deliberately constructed and maintained to enforce racial segregation."

But not long after, another series of court decisions would unwind those outcomes. Fifty years ago, in *Milliken v. Bradley*, the court struck down a plan for integrating Detroit public schools across school district lines. The ruling undermined desegregation efforts in the north and Midwest, where small districts allowed white families to escape integration.

Other decisions followed. In *Freeman v. Pitts*, the court ruled resegregation from private choice and demographic shifts could not be monitored by the court. More than 200 districts were released from court-monitored desegregation plans. By 2007, when the court ruled in *Parents Involved v. Seattle Public Schools*, even voluntary integration plans could no longer consider assigning students on the basis of race.

"If you have the tools taken away from you ... by the Supreme Court, then you really don't have a whole lot of tools," said Stephan Blanford, a former Seattle Public Schools board member.
