we've got all the worst-case scenarios resolved ... (because) what might have been safe 25 years ago probably is no longer safe."

That realization has begun to change how the government addresses threats at some of the nation's most sensitive sites.

The Department of Energy in 2022 required its existing sites to assess climate change risks to "mission-critical functions and operations," including waste storage, and to develop plans to address them. It cited wildfires at Los Alamos and Lawrence Livermore national laboratories and a 2021 deep freeze that damaged "critical facilities" at Pantex.

Yet the agency does not specifically consider future climate risks when issuing permits or licenses for new sites or projects, or in environmental assessments that are reviewed every five years though rarely updated. Instead, it only considers how sites themselves might affect climate change — a paradox critics call short-sighted and potentially dangerous.

Likewise, the Nuclear Regulatory Commission considers only historical climate data rather than future projections in licensing decisions and oversight of nuclear power plants, according to a General Accounting Office study in April that recommended the NRC "fully consider potential climate change effects." The GAO found that 60 of 75 U.S. plants were in areas with high flood hazard and 16 were in areas with high wildfire potential.

"We're acting like ... (what's) happening now is what we can expect to happen in 50 years," said Caroline Reiser, a climate and energy attorney at the Natural Resources Defense Council. "The reality of what our climate is doing has shifted dramatically, and we need to shift our planning ... before we experience more and more of the extreme weather events."

The National Nuclear Security Administration's environmental safety and health division, which oversees active DOE sites, will conduct an internal review and convene a work group to develop "crucial" methodologies to address climate risks in permitting, licensing and site-wide assessments, John Weckerle, the division's director of environmental regulatory affairs, told The Associated Press.

different latitudes during an 11-year cycle. They fed their calculations into a NASA supercomputer in Northern California — the same one used in the 2015 movie "The Martian" to verify the best flight path to rescue the main character. The results suggested a shallow magnetic field and additional research is needed to confirm this.

The modeling was "highly simplified," University of Wisconsin-Madison's Ellen Zweibel, who was not part of the team, said in an accompanying editorial.

The results are intriguing and "sure to inspire future studies," Zweibel said.

The new knowledge should improve long-term solar forecasts, allowing scientists to better predict the strength of our star's future cycles. The sun is approaching its peak level of activity in the current 11-year cycle, thus the recent flareups.

Strong solar flares and outbursts of billions of tons of plasma earlier this month unleashed severe solar storms that produced auroras in unexpected places. Last week, the sun spewed out the biggest solar flare in almost 20 years, but it steered clear of Earth.

Better understanding of the sun can ensure "we are prepared for when the next storm — potentially much more dangerous — hits Earth," Lecoanet said.

mate change include the University of Washington, Yale University, Utah State University, the University of Montana, Northern Vermont University and the University of California, Los Angeles. Columbia, the private university in New York City, opened its Climate School in 2020 with a graduate degree in climate and society, and has related undergraduate programs in the works.

Just in the past 4 years, the public Plymouth State University in New Hampshire, Iowa State, Nashville private university Vanderbilt, Stanford University, the Massachusetts Institute of Technology and others have started climate-related studies. Hampton University, a private, historically Black university in Virginia, is building one now, and the University of Texas at Austin will offer theirs this fall.

move at different speeds. If the difference in speed is big enough, the atmosphere can't handle the strain, and it breaks into turbulent patterns like eddies in water.

"When you get strong wind shear near the jet stream, it can cause the air to (overturn). And that creates these chaotic motions in the air," Thomas Guinn, chair of applied aviation sciences department at Embry-Riddle Aeronautical University in Daytona Beach, Florida, explained.
