would prefer full-time work rose, extending a year-long trend.

"When you look under the hood, you're seeing numbers that confirm that the job market is on that cooling trajectory," Zhao said.

America's labor market is now in an unusual place: Jobholders are mostly secure, with layoffs low, historically speaking. Yet with the pace of hiring having weakened, landing a job has become harder.

Over the past three months, job growth has averaged only 116,000 a month, down sharply from an average of 211,000 a year ago. Over time, that may not be enough to keep up with growth in the number of people looking for work, economists say. An influx of immigrants in the past three years has enlarged the nation's workforce.

ist Ben Horowitz on a podcast this summer. "Well, what if that's the size of the model you need to, like, cure cancer?"

An executive order signed by President Joe Biden last year relies on a 10 to the 26th threshold. So does California's newly passed AI safety legislation — which Gov. Gavin Newsom has until Sept. 30 to sign into law or veto. California adds a second metric to the equation: regulated AI models must also cost at least \$100 million to build.

Following Biden's footsteps, the European Union's sweeping AI Act also measures floating-point operations, but sets the bar 10 times lower at 10 to the 25th power. That covers some AI systems already in operation. China's government has also looked at measuring computing power to determine which AI systems need safeguards.

according to guidance from the National Child Traumatic Stress Network. Being available and patient is key.

This isn't just a job for parents and guardians. All adults should remember to be available for the kids in their life. After all, not all children have trusted adults they can speak with, said Crystal Garrant, chief program officer at Sandy Hook Promise, a nonprofit group that works to prevent suicides and mass shootings.

For instance, she said, adults who work in before-school or after-school programs should ask the kids in their care open-ended questions, do community-building activities or provide kids with other opportunities to share openly. They may not have the opportunity to do so otherwise.

Tailor the talk to the child's age

How much children are able to understand a situation will depend on their age and development, Ney said.

"There is no specific age target for these conversations," said Garrant, who has a 9-year-old daughter. "But make sure that younger children understand the word that you're using. When we say safety, what does it mean to feel safe? How does it feel in your body? What does it sound like when you're not safe?"

Some children may have emotional and behavioral responses to traumatic events, such as anxiety, nightmares or difficulty concentrating.

Younger children need simple information and reassurances their schools and homes are safe, guidance from the National Association of School Psychologists notes. Older children have a deeper capacity for understanding and could benefit from hearing about what agency they might have to keep themselves safe.

1,000 higher. The biggest variations were in professional and business services (-358,000), leisure and hospitality (-150,000), retail trade (-129,000), and manufacturing (-115,000). Some industries were underestimated, including private education and health services (+87,000) and transportation and warehousing (+56,400).

The revision won't be officially implemented until March 2025, but the announcement still provides useful context. While the US economy has been adding jobs, the pace has been weaker than indicated. Although revisions are simply part of a process that has persisted for decades, the timing both reinforces recent Federal Reserve indications of lower interest rates ahead and provides insights into challenges in the efforts to simultaneously achieve price stability and full employment.
